



## The FurKids Club LLC Membership Agreement

This agreement is between The FurKids Club LLC (hereinafter called "The FurKids Club" or "TFKC") and Owner/agent of dog(s) (hereinafter called "Owner" or "Authorized agent") listed in TFKC electronic records and/or below. This form is inclusive and applies to all dogs in household registered as TFKC Club members.

In entering into this Agreement, I **certify I am the legal Owner or Authorized agent of the dog(s)** listed in TFKC electronic records or named below, and I have the authorization to enter into and sign this agreement and to enroll and place my dog(s) in The FurKids Club Services. I further certify that all information given about my dog(s), is true and accurate and understand The FurKids Club LLC has relied upon my representation, and that The FurKids Club LLC reserves the right to deny admittance to any dog for any reason at any time.

I further represent, understand, and/or agree that **there are minimum requirements for my dog(s) to obtain membership and attend TFKC services. I understand and agree that my dog(s):**

1. Are at least 4 months (16 weeks) of age
2. Required to be neutered if male and 6 months or older, and if female and intact, cannot attend TFKC services while in-heat.
3. Required to pass a 3-hour trial Meet & Greet (temperament test) for determination of suitability for open group play to TFKC's satisfaction and in its sole discretion. If the dog(s) have been absent 6 months or greater from TFKC services, they may be required to repeat the temperament test. Any dog who has been absent 12 months or longer is required to attend a new Meet & Greet.
4. Non-aggressive toward other dogs or humans, not destructive, not extremely dominant, or fearful, plays well with others and well mannered.
5. Required to **wear a quick release collar** that contains an identification tag with name of dog and Owners current contact information. I understand that NO pinch, choke, metal, beaded, or studded collars are allowed, and this is for the safety of my dog(s) or other dogs/people at TFKC.
6. Required to **be on leash** and under my control when entering and exiting TFKC facilities.

### HEALTH & WELL BEING

1. Currently up to date on all required vaccinations to include: Rabies, DHPP (Distemper, Hepatitis, Parvo, Parainfluenza) within the last year. Bordetella (kennel cough) within last 6 months. Test negative for heartworm and negative fecal float test within last 6 months. I am responsible for keeping my dog up-to-date on vaccinations and required to provide **HARD COPY PROOF** from his/her veterinarian.
2. My dog(s) will not be allowed to attend services at TFKC if their vaccinations are expired by even one day. TFKC takes health and safety seriously and works to reduce risk of exposure of illness.
3. In good health, and free of contagious parasitic problems, whether internal or external (including fleas and ticks), and is free of any contagious illness, disease, or skin disorder.
4. That although preventative measures are taken, no amount of vaccination requirement, sanitation efforts of the facility, or the care provided to the dog(s) can guarantee to prevent a dog from contracting an airborne virus or communicable disease.
5. On veterinarian **approved flea and tick prevention**. Since fleas and ticks are easily transmitted from dog to dog, I agree that if TFKC Staff sees fleas on my dog(s), they WILL bathe & treat, and a charge of \$20 will be added to my account. If bathing treatment is not effective, you will be contacted and have the option to come pick up your dog, or we will provide a topical flea treatment in house for a fee of \$20.
6. **If my dog is taking medication**, I give consent to TFKC to administer the medication. I agree to fill out the Medication Management Form with clear instructions, and understand/agree that the medication must be brought in the **original container**, labeled with dosage and administration instructions clearly written, and the name of the Veterinarian on the container.
7. **If my dog(s) show signs of illness or is injured**, TFKC will attempt to contact me or my designated emergency contact. In the event neither person is able to be reached, I hereby authorize TFKC to make all health care decisions for my dog(s) and treat illness or injury as deemed best by staff of TFKC, and in their sole discretion, in the best interest of the dog(s).
8. **I have reviewed, agreed with and signed The FurKids Club LLC Medical Consent & Care Policy Agreement** and in case of an emergency, I give full consent to TFKC to take my dog to the veterinarian of their choice for treatment of injury/illness or other requisite treatment. I understand and agree that I am solely financially responsible for all fees and costs associated.

## ACCEPTANCE AND ACKNOWLEDGEMENT OF RISK

I understand and agree that:

1. The FurKids Club provides a supervised, open arena dog daycare, with group play and cage-free boarding, where social interaction between dogs and humans is encouraged. While the socialization and play is carefully monitored by TFKC Staff, dogs are unpredictable, and it is still possible during the course of normal play that my dog may receive minor injuries while rough-housing or play with other dogs.
2. I understand and agree that more serious injuries cannot be predicted, but I am aware harm, disability, or loss could come to my dog(s) due to the nature of cage-free setting.
3. I am aware of the inherent risks and benefits associated with open arena group play. I agree that the benefits outweigh the risks and I accept all risk as I desire a socialized open play environment for my dog while attending services in the care of TFKC and TFKC is not responsible financially for any vet fees or other costs associated/incurred as a results of injury to my dog.

## SAFETY AND BEHAVIOR

I further understand and agree that:

1. The overall safety and well being of every FurKid member (dog) is the utmost concern of TFKC staff. While I feel that open play would be a good setting for my dog(s) to socialize, not all dogs do well going directly to boarding. **If my dog passes the temperament test he/she will be required to complete a full day of daycare (minimum 6 hours)**, separate from date of suitability testing or any boarding reservation, to ensure my dogs' comfort level with group socialization.
2. Any dog that misbehaves or becomes aggressive will be given a time out from the daycare area.
3. If my dog has more than two time outs during a stay, he/she may be removed from open play and put in a kennel/run, taken out to play and use the restroom by TFKC staff throughout their visit, however they will no longer participate in open group play.
4. If TFKC staff feels that any dog(s) is/are a risk to other dogs or to people at anytime, or behavior is such that causes continual disruption to TFKC staff and/or other dogs, TFKC reserves the right to require obedience training prior to any further reservations and/or refuse service and revoke club membership to any dog at any time.
5. My dog has never shown aggression or threatening behavior towards/injured other dogs or humans. I understand that if my dog has behavioral issues or aggressive behavior that is deemed unsuitable for Temperament Test, PlayCare or StayCare interaction, that my dog will no longer be able to attend TFKC but may be offered in-home care services solely at TFKC discretion. TFKC has a ZERO TOLERANCE policy for aggressive behavior.
6. I understand that if my dog causes any damage to TFKC site where services are provided, another dog or otherwise, I am liable for the full cost of all treatment, repairs and replacements.

## PERSONAL PROPERTY

- ⇒ TFKC provides beds, bedding, and storage for your dogs' food, therefore it is recommended you leave such items at home. TFKC is not responsible for any of my personal property such as blankets, leashes, collars, crates, or food containers. If you prefer your dog(s) be crated at night, we have crates available. If you would prefer your dog be in their own crate, please make arrangements with the Customer Care Team.

## FOOD/FEEDING

- ⇒ That I am encouraged to bring my dogs' own home from food as it is best on their digestive system to remain consistent on food intake. I will not be charged for TFKC to feed my dog their own food from home, but there are fees associated if TFKC must feed my dog their food. I have reviewed these fees in "Hours, Rates, and Services Agreement."
- ⇒ I have made TFKC staff members aware of any/all food or other allergies that my dog may have.

**PHOTO RELEASE**

- ⇒ I give my full consent that My dog(s) may appear in picture or likeness on any digital or hardcopy-printed publications without compensation. TFKC has my permission to label any pictures of my dog(s) with their FurKid name. I may request access to digital copies that may be uploaded to my dogs’ TFKC electronic record.

**ATTENDANCE**

- ⇒ The FurKids Club operates 24/7, 365 days a year (and that 1 day in leap year).
- ⇒ **Lobby and daycare hours are: 7:00am to 7:00pm daily, except major holidays.** Our Customer Care Team answers the phone up until 8:00pm. Please check our postings in our lobby, on FB, and our website for notification regarding Holiday Hours. We have staff who are trained in basic dog handling, animal first aid, and dog CPR, providing loving, attentive care for your furry family members!

**RATES, DEPOSIT REQUIREMENTS, CANCELATION POLICY, AND LATES FESS**

- ⇒ I have reviewed the Hours, Rates, Deposit Requirements, Cancellation Policy, Fees and Services in the “**Hours, Rates and Services Pawticulars**” and agree to abide by the policies set forth by TFKC.
- ⇒ I understand there are late fees associated with not picking my dog(s) up at the stated required times and that my dog(s) may also end up with an overnight stay and boarding charge if not picked up by close of lobby hours and this charge will be added to my account.
- ⇒ **I understand that rates and fee pricing is/are subject to change without notice.** I understand and agree that it is MY responsibility to review the current rates and services information prior to making a reservation.

**INDEMINIFICATION**

I certify I am the Owner/agent of said dog(s) and I have read, reviewed, understand, accept, and will abide by the entire contents of this agreement. (a) there are inherent and potential risks involved with interactions between humans and dogs, and between dogs and other dogs, which may result in property damage or bodily injury, including but not limited to: permanent disability, sickness or death to human or dog; and (b) there may be other risks not known to me or to The FurKids Club LLC, not readily foreseeable at this time (collectively “risks”). (c) I fully accept and assume all risks and responsibility for all risks including, without limitation, all liabilities, claims, losses, costs, expenses (to include legal fees), and damages incurred as a result of my dogs’ acts, behavior, or participation at The FurKids Club LLC services, including any veterinarian expenses incurred on behalf of or caused by my dog. (d) If my dog(s) are transported to or from TFKC facility by staff, that I will forever hold harmless, The FurKids Club LLC, it staff, representatives or heirs in the event of an injury or accident during transportation. (e) I understand and agree that I am solely responsible for payment in full upon services rendered and for any costs or fees associated. I further hereby fully release, indemnify and forever hold harmless The FurKids Club LLC its employees, representatives, heirs, and guests from any and all liabilities (including attorney’s fees) arising out of or connected with injuries/harm to persons, dogs, or property; or illness/disease, loss, theft, damage, fire, escape, natural disasters or death, which arise in any way out of services, facilities, and/or products provided by, or as a consequence of my association with The FurKids Club LLC. I further understand and agree that in the even that any portion of this agreement shall be found void or unenforceable for any reason: all other portions of the agreement will remain in full force and effect. By signing below, I acknowledge that I have read, understand, and accept all terms outlined above. If signing electronically, I hereby agree that my signature will be deemed a legal original and take the place of my wet-ink signature. If signing in ink, I hereby agree that a true and correct copy of this document may be produced in lieu of the original agreement and the copy is legally enforceable and does not affect the terms of the agreement in any way.
